Sir/Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter 4-7/2025-26/NCH(MA&RB)/(109-41)/1328 dated 02.05.2025, Nootan Homoeopathic Medical College and Hospital, Nootan Sarva Vidyalaya Kellarani Mandal, Sankalchand Patel Vidyadham Ambaji Gandhi Nagar Star Highway Visnagar, Gujarat-384315 has filed an appeal to the commission against the decision of MARBH vide their letter no. NHMCH/MARBH/2025/809 dated 27.05.2025.

Commission has recommended MARBH vide letter no. 30-5/2025-26/NCH-GR(8)/2676 dated 26.06.2025 for the continuation of permission for 100 seats for 1st BHMS course to Nootan Homoeopathic Medical College and Hospital, Nootan Sarva Vidyalaya Kellarani Mandal, Sankalchand Patel Vidyadham Ambaji Gandhi Nagar Star Highway Visnagar, Gujarat-384315 for the academic year 2025-26. Accordingly, MARBH is granting Conditional Permission for 100 seats for BHMS Course for the academic year 2025-26 based on the following conditions:

- i. The College shall provide AERB and Skill lab documents within 01 month
- ii. The College shall appoint MQRL approved and NTET qualified teaching staff and submit the qualification documents of all teaching staff.
- iii. The college must make AEBAS machine functional within period of one month.


All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance with MES-2024 anytime during the academic year.
